## Notice of Revocation of Massage Establishment License Louisiana Board of Massage Therapy

**Action:** Effective September 13, 2018, Massage Establishment License E3915 issued in the name of Wonderful Massage & Spa has been revoked.

**Reason for action:** The Louisiana Board of Massage Therapy ("board") conducted an inspection of the establishment location on 5/24/2018 and certain violations of board rules and regulations were noted. A formal notice of violation and imposition of a fine was sent via certified mail to the establishment on June 8, 2018 which was acknowledged received on June 13, 2018. A second notice was sent via certified mail on August 2, 2018, which was received on August 8, 2018, advising that the establishment had 15 days to pay the outstanding fine and show that the violations had been corrected or file a notice of intent to contest the violation. The notice also provided that a failure to act would result in a revocation of licensure. Wonderful Massage & Spa has not paid the fine, filed a notice of intent to contest the violations, or otherwise communicated with the board office.

The failure of the establishment to pay the fine and correct the noted violations justifies revocation under La. R.S. 37:3563 (A) which provides: "The board may suspend, revoke, or refuse to issue or renew a license after notice and opportunity for hearing pursuant to the Administrative Procedure Act, upon proof on any of the following:

. . . (6) Violating or aiding and abetting in the violation of any provisions of this Chapter or the rules and regulations promulgated hereunder."

**Sanctions:** Establishment License E3915 is revoked and Wonderful Massage & Spa is prohibited from operating a business which engages in the practice of massage therapy and any continuation of

such practice is a violation of La. R. S. 37:3556 and may give rise to criminal sanctions under R. S. 37:3565. In addition, Yong Sun, as the registered owner of Wonderful Massage & Spa, shall be ineligible for future licensure as an owner or operator of a massage establishment until such time as the fines and violations associated with the revocation have been resolved.

**Notice of Intent to Contest:** Unless a written Notice of Intent to Contest this revocation is filed with the board office within 15 days of this Notice of Revocation, the revocation will be final and will not be subject to appeal.
