VOLUNTARY SURRENDER OF LICENSE

WHEREAS, LILI WEI ("Ms. Wei") is the owner of a licensed massage establishment in the State of Louisiana as evidenced by LBMT License No. E4512 (Relax Spa 2, LLC "Relax Spa"), and is subject to the jurisdiction and rules and regulations of the Louisiana Massage Therapists and Massage Establishments Act (La. R.S. 37:3551, et seq.), and the rules promulgated by the Louisiana Board of Massage Therapy ("LBMT") (LAC 46:XLIV §101, et seq.);

WHEREAS, in association with a LBMT license application received by the LBMT, the LBMT, in searching websites where businesses offering illicit services and/or illegal prostitution regularly advertise, determined that the number and address for Relax Spa were located on several illicit websites;

WHEREAS, Ms. Wei acknowledged that the telephone number and address associated with Relax Spa were used in advertisements on several illicit websites, but denied that the ads were placed during her ownership of Relax Spa;

WHEREAS, on August 23, 2024, the LBMT approved a Consent Agreement and Order related to Relax Spa whereby the establishment license of Relax Spa was placed on probation for a period of one (1) year, during which time Relax Spa was required to comply with numerous requirements as set forth in the Consent Agreement and Order;

WHEREAS, an inspection was conducted at Relax Spa, during which an unlicensed female was found to be providing massage therapy services, and other violations were also discovered;

WHEREAS, the respondent, Ms. Wei, has indicated her desire to voluntarily surrender her establishment license with the LBMT, particularly License No. E4512 (Relax Spa 2), in lieu of further disciplinary proceedings;

WHEREAS, the respondent, Ms. Wei, acknowledges that in accordance with the written policies of the LBMT, the following will result due to the voluntary surrender of her license:

- 1. Public notification of this Voluntary Surrender of License by posting a copy of this Voluntary Surrender of License on the LBMT website.
- 2. She shall be ineligible for reinstatement of her establishment license in the state of Louisiana and shall be ineligible to apply for a new establishment license for a period of five (5) years.

WHEREAS, Ms. Wei agrees that she shall pay costs associated with the investigation of this matter in the amount of \$500.00 when she submits this Voluntary Surrender of License to be approved by the LBMT, which amount shall be made by certified check or money order;

WHEREAS, Ms. Wei acknowledges that she has had the opportunity to thoroughly review the contents of this Voluntary Surrender of License, and that she is informed of and understands her rights, including her rights to due process in connection with this Voluntary Surrender of License, and that she has been represented by counsel with regarding to this Voluntary Surrender of License;

WHEREAS, Ms. Wei further acknowledges that failure to reimburse the costs set forth above will require the Board to take further action in collection of this debt. Respondent has thirty (30) days to reimburse the expenses before the debt will be considered final and transferred to the Louisiana Office of Debt Recovery (ODR). After transfer, the debt is subject to an additional

collection fee of up to twenty-five percent (25%) of the total debt liability, as provided for in La. R.S. 47:1676(E);

WHEREAS, by the voluntary surrender of his license, Ms. Wei, moreover, acknowledges, stipulates, and agrees that she hereby waives any right to which she may be entitled pursuant to the Louisiana Administrative Procedure Act or which otherwise may be afforded to her by law, to contest her agreement to, or the force and effect of this document in any Court related to the matters referred to herein, and further waives the right to appeal the acceptance and approval of this Agreement by the LBMT;

WHEREAS, Ms. Wei acknowledges that she has had the opportunity to seek the advice and guidance of legal counsel with respect to this Voluntary Surrender of License;

WHEREAS, based on the above, LILI WEI surrenders her establishment license held with the LBMT, particularly License No. E4512 (RELAX SPA 2, LLC).
