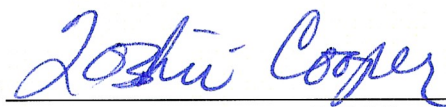
Motion to adjourn meeting at 12:16 pm by Karla Swacker and seconded by Toshii Cooper. Motion carried unanimously
